• Temperature change detection

An event is generated when the temperature value of the camera input image is analyzed and is larger or smaller than the threshold value.

• Supports VGA pixel resolution videos

VGA-resolution (640x480 pixels) thermal camera: The thermal camera is a device that displays the temperature distribution in a VGA-resolution (640X480) thermal image by sensing the surface temperature of the object in a noncontact manner.

Multi-Streaming

This network camera can display videos in different resolutions and qualities simultaneously using different CODECs.

INSTALLATION

Precautions before installation

Ensure you read out the following instructions before installing the camera:


- Install the system based on the following directions. If you want to install using a different method, you should confirm the safety recommendations by making a request to the manufacturer in advance.
- The gross weight of the system is 11.7 kg. A pair of anti-slip gloves must be worn. When you lift your device, do not grab the camera but the body.
- It must be installed on the area (ceiling or wall) that can withstand 4 times the weight of the camera including the installation bracket.
- Stuck-in or peeled-off cables can cause damage to the product or a fire.
- For safety purposes, keep anyone else away from the installation site. And put aside personal belongings from the site, just in case.

Optional Accessories for Installation

For your easier installation, you can purchase appropriate optional accessories available.

Mounting on wall using bracket


1. Connect the side of the bracket to the wall using 4 anchor bolts (not supplied).



- We recommend using M10X30 anchor bolts or better to install the camera on concrete.
- Use screws that can withstand more than four times the weight of the equipment.

Install the device on the floor


1. Install the pedestal on the floor.



We recommend using M10X30 anchor bolts or better to install the camera on concrete.






INSERTING/REMOVING A MICRO SD MEMORY CARD

- Disconnect the power cable from the camera before inserting the Micro SD memory card.
- Do not insert the Micro SD memory card while it's upside down by force.
 Otherwise, it may damage the Micro SD memory card.
- When it rains or the humidity is high, insertion or ejection of a Micro SD card is not recommended.


Separating the Micro SD card insert cover




Micro SD/SDHC/SDXC

- Pressing too hard on the Micro SD memory card can cause the card to shoot out uncontrollably from the slot when released.
- Before removing the Micro SD memory card, in <Storage>, set the device to <Off> and press the [Apply] button and turn the camera off.
- If you turn off the camera or remove the Micro SD memory card that contains data from the product, the data may be lost or damaged.




Connecting to Audio Input/Output

installation & connection

How to connect the RJ45 waterproof cable to a LAN cable

1. Insert it through the arrow direction.



2. Connect the LAN connector (male) to the cable.



RJ45 modular jack (female) Rubber ring **RJ45** connector

3. Connect the RJ45 modular jack (female) to the RJ45 connector (male).

Please, keep each of the parts separated.

4. Assemble by rotating the RJ45 modular jack (female) and the RJ45 protection cover clockwise (Follow the arrow).



5. Assemble by rotating RJ45 protection cover and back cover clockwise (Follow the arrow).


When the back cover is assembled, the cable waterproof gasket is tightly attached to the cable to make it waterproof.

You must fully assemble it to rotate the back cover up to the end of the screw thread of the RJ45 connector.

Outdoor installation

When you install it outside of the building, please waterproof it with waterproof butyl rubber tape (can be purchased in stores) so that water does not leak from the gap of the cable connected to the outside.

- 1. Connect the power, I/O, AUDIO, and LAN cables.
- Wrap the black cable jacket (Area A) and the cable connection area with waterproof (butyl rubber) tape so that more than half of the butyl rubber tape is overlapped.



- If the cable jacket is not waterproofed properly, then it can directly cause leakage. Make sure to protect the cable with a dense layer of taping.
- Waterproof butyl tape is made of butyl rubber that can be stretched to twice its normal length.
- You do not need to wrap butyl rubber tape separately since LAN connector cable is waterproof.






- A remote PC in an external Internet out of the LAN network may not be able to connect to the camera installed in the intranet if the port-forwarding is not properly set or a firewall is set. In this case, to resolve the problem, contact your network administrator.
- In the Device Manager, you can use the initial password, "4321" to set IP Address, Subnet Mask, Gateway, HTTP Port, VNP Port, IP type. After changing the network interface, for better security, access the web viewer and change the password.
- By factory default, the IP address will be assigned from the DHCP server automatically. If there is no DHCP server available, the IP address will be set to 192.168.1.100. To change the IP address, use the Device Manager. For further details on Device Manager use, refer to "Using Device Manager". (Page 17)



AUTOMATICALLY SEARCHING CAMERA

If a camera is connected to the same network of the PC where device manager is installed, you can find network camera by using search function.

CONFIGURING IP ADDRESS

If you want to change camera network setting, <Login OK> sign must be displayed at <Status>. Click <Authentication> at the main page to log in.

Configuring Static IP

Manually insert and configure IP address & port information.

- Click the camera from the list that you want the change the IP setting.
- 2. Click <**IP Assign**> at the main page of device manager.
- 3. Select < Assign the following IP address>.
 - IP information of the camera will be displayed as previously set.
- 4. Fill in IP & Port related categories.

If not using a Broadband Router

For setting <IP Address>, <Subnet Mask>, and <Gateway>, contact your network administrator.

- HTTP Port : Used to access the camera using the Internet browser, defaulted to 80.
- VNP Port : Used to control the video signal transfer, defaulted to 4520.
- RTSP Port: A port that controls real-time streaming. The initial value is 554.

If using a Broadband Router

- IP Address : Enter an address falling in the IP range provided by the Broadband Router.
 ex) 192.168.1.2~254, 192.168.0.2~254,
- 192.168.XXX.2~254
- Subnet Mask : The <**Subnet Mask**> of the Broadband Router will be the <**Subnet Mask**> of the camera.
- Gateway: The <Local IP Address> of the Broadband Router will be the <Gateway> of the camera.



- The settings may differ depending on the connected Broadband Router model. For more information, refer to the user manual of the applicable router.



Once you register a dynamic IP-based device with the DDNS server, you can easily check the changed IP when you try to access the device.

PLUG-IN SUPPORT SPECIFICATIONS FOR EACH BROWSER

The existing plug-in web viewer and a new plug-in free web view is embedded together.

This allows you to use the web viewer in newer browser environments that do not support plug-ins, such as Chrome, EDGE and FireFox (Windows 64-bit only). For browsers that allow the installation of plug-ins, such as IE and Safari, installing the plug-in is recommended.

According to the browser environment, the following differences may be observed.

- Chrome, FireFox(Windows 64bit only), EDGE browser : Although they don't support plug-ins, you can use a
 web viewer as a plug-in free web viewer is embedded.

It was made to prevent issues such as increased latency and no response from the browser when playing the video on a system with lower hardware specifications than recommended. The video profile is reduced in the following sequence: 1920X1080(20fps) → 1280X720(20fps) → 640X480(20fps).
- IE, Safari browser : You can use a web viewer even if you don't install the existing plug-in web viewer.
 - To monitor/play saved video seamlessly, you are required to install a plug-in.

INSTALLING WebViewer PLUGIN

Although it is not possible to install plug-ins separately If you access the camera from Google Chrome, Mozilla Firefox, or the MS Edge web browser, you can view and control the camera video without installing plug-ins.






